- March 20 2024 Governing Board report
 - The following is the Academic Senate Governing Board Report for March 20, 2024
 - Faculty Tenure Reception
 - Thank you to Lissa Napoli for planning and executing a wonderful tenure reception event. Each year, Academic Senate hosts a Tenure Reception event to honor the faculty that have been granted tenure. Due to the pandemic, these receptions were put on hold. On Tuesday March 19, Academic Senate hosted the first Tenure Reception event since spring 2019. Honorees included tenured faculty for the 2019-2020, 2020-2021, 2021-2022, and 2022-2023 academic years. In other words, faculty that were hired full-time for fall 2016 through fall 2019 were honored yesterday.
 - To convey the significance of faculty tenure, I'd like to share selected text from AB 1725 (Vasconcellos, 1988).
 - Section 4 (n) It is a general purpose of this act to improve academic quality, and to that end, the Legislature specifically intends to authorize more responsibility for faculty members in duties that are incidental to their primary professional duties.

- Section 4 (w) Faculty tenure fosters academic freedom and should be maintained. A person should be granted tenure as a faculty member only after it has been determined through a process of evaluation that he or she is, and will likely continue to be, a positive asset to the community college. In other words, the award of tenure should be an affirmative act, rather than the result of default.
- Section 4 (1) The tenure system is an important prerequisite for the maintenance of academic freedom, continuity in academic and vocational programs, and development of a faculty committed to the long-term health of the community colleges. At the same time, the tenure system is a central part of the governance of the colleges. Thus, the determination of standards for tenure, procedures governing tenure, and the actual granting of tenure determine in large part the substantive direction of the colleges.

AP 4100 Graduation Requirements for Degrees and Certificates

Associate Degrees

For the Associate in Arts (A.A.) or Associate in Science (A.S.) degree, a student must demonstrate competence in reading, written expression, and mathematics, and satisfactory completion of a course in ethnic studies. The Associate in Arts (A.A.) Degree or Associate in Science (A.S.) Degree will be awarded to any student upon satisfactory completion of all of the following requirements:

- 1. Competency Requirements +NO Competency requirements +
 - a. Mathematics Competence Proficiency in Mathematics may be satisfied by one of the following:
 - i. Placement into MATH 25 or higher as determined by the Chaffey assessment process or
 - ii. Successful completion (grade "C" or higher) of one of the intermediate algebra or higher level math or statistics courses listed here: MATH 25, 31, 60, 61, 65A, 65B, 75, 81, 85; SOCIAL SCIENCE 10; STATISTICS 10
 - b. Reading and Writing Competence Proficiency in reading and writing may be satisfied by the following:
 - i. Successful completion of ENGLISH 1A (grade "C" or higher).
- Sixty (60) units of accredited lower division college credit in courses that have been properly approved pursuant to Title 5 Section 55002(a).
 - Foundational courses numbered in the 500's and 600's do not apply toward the 60 units required for graduation.
 - Students may petition to have noncredit courses counted toward the satisfaction of requirement for an associate degree.

2. 3. Major Requirement

Completion of at least 18 units with a grade of "C" or better in each course attempted that is counted toward the major.

3 34. General Education

- Completion of one of the following options:
 - o Option I: 18 units as stipulated by the Chaffey College Catalog; or
 - o Option II: 39 units stipulated by the CSU general education certification requirements; or
 - Option III: 34 units as stipulated by the completion of the IGETC.; or
- There is no limit on the number of units that may count towards both general education and major requirements.
- Note: A multi-cultural (ethnic studies) course is offered in at least one of the general education areas listed above.
- A definition of "college work" that provides that courses acceptable toward the associate degree include those that have been properly approved pursuant to Title 5 Section 55002(a), or, if completed at other than a California community college, would reasonably be expected to meet the standards of that section.
- The general education requirements must include course work in the natural sciences, the social and behavioral sciences, humanities, and language and rationality.
- Students may petition to have noncredit courses counted toward the satisfaction of requirements for an associate degree.
- District policies and procedures regarding general education and degree requirements must be published in the college catalog and must be filed with the State Chancellor's Office.

4.5. Residence Requirement

Successful completion of a minimum of 12 units in residence. The Governing Board may excuse the residence requirement to alleviate injustice or undue hardship.

5. 6. Scholarship Requirements

All degree requirements including General Education must be completed with an overall grade point average of 2.0 ("C") or better. In addition, all courses that

count toward the Associate Degree major or area of emphasis must be satisfactorily completed with grades of "A", "B", "C", or "P".

From U.S. accredited colleges: Credit for college-level courses completed at other accredited education institutions will be evaluated for content quality upon receipt of an official transcript and completion of a Request for Unit Evaluation form in the Admissions and Records Office. Full unit credit normally will be granted.

From foreign colleges: Transcripts from foreign colleges and universities will be accepted only when evaluated by an evaluating service recognized by Chaffey College. Credits from an evaluation service are counted as earned credits only. Grade point averages from foreign institution are not included on the Chaffey academic transcript.

7. %. Graduation/Certificate Application

Students must file a formal application for graduation in the College Counseling Center. Students may graduate at the end of any semester or summer session.

Graduation requirement must come from a single catalog.

A student who receives an associate degree may subsequently or simultaneously work on additional degrees.

6. 9. Financial Responsibility

Student grades, transcripts, enrollment and degree verifications, diplomas, and registration privileges records will be withheld in accordance with law pending settlement of any outstanding financial obligation to the District. (Review note: See Education Code §66022, Title 5 §59410, and the Educational Debt Collection Practices Act, which prohibit withholding grades, transcripts, and registration privileges. BP/AP 5035 Withholding of Student Records will be revised to reflect legislative changes.)

Within the graduation requirement for the associate degree at Chaffey College, it is possible for a student to complete the requirements for more than one major providing that minimum requirements are met for each major.

Associate Degrees for Transfer

The Associate Degree for Transfer will be awarded to any student upon satisfactory completion of the following requirements:

- Minimum of 60 CSU-transferable semester units.
- 2. Minimum grade point average (GPA) of at least 2.0 in all CSU-transferable coursework.
- Completion of a minimum of 18 semester units in an "AA-T" or "AS-T" major. All
 courses in the major must be completed with a grade of "C" or better or a "P" if
 the course is taken on a "pass-no pass" basis.
- 4. Completion of one of the General Education Patterns listed below:
 - Option I: CSU General Education requirements; or
 - Option II: Intersegmental General Education Transfer Curriculum (IGETC) that must include an Oral Communication course (Area 1 Group C); or
 - Option III: IGETC for STEM that must include an Oral Communication course (Area 1 Group C) if option is indicated in the specific degree description; or
 - Option IV: CSU GE Breadth for STEM if option is indicated in the specific degree description; or
 - Option V: 16-20 units of IGETC general education for an Associate in Science for University of California (UC) transfer, or
 - · Option VI: CalGETC requirements.

Certificates of Achievement are state-approved certificate programs of study consisting of 16 or more semester units of degree-applicable coursework. These certificates appear by name on the student's transcript. These certificates must:

- Be consistent with the mission of the District
- Meet a demonstrated need
- Be feasible and adhere to guidelines on academic achievement
- Demonstrate a well-defined pattern of learning experiences designed to develop certain capabilities that may be oriented to career or general education. (Program and Course Approval Handbook)

A Certificate of Achievement will be awarded upon satisfactory completion of the following requirements:

- Successful completion of a course of study (grade point average of 2.0 or higher) or curriculum that consists of 16 or more semester units of degreeapplicable credit coursework
- b. An application for graduation/certificate together with relevant petitions and official transcripts by stipulated deadlines.

2. Certificates of Career Preparation

Certificates of Career Preparation are locally-approved certificate programs of study consisting of fewer than 18 units of degree-applicable coursework. These certificates do not show up on a student's transcript. These certificates must:

- Be consistent with the mission of the District
- Meet a demonstrated need
- Be feasible and adhere to guidelines on academic achievement
- Not require California Community Colleges Chancellor's Office approval
- Demonstrate a well-defined pattern of learning experiences designed to develop certain capabilities that may be oriented to career or general education. (Program and Course Approval Handbook)

A Certificate of Career Preparation will be awarded upon satisfactory completion of the following requirements:

- a. Successful completion of a course of study or curriculum (grade point average 2.0 or higher) that consists of fewer than 18 semester units of degree-applicable credit coursework
- b. An application for graduation/certificate together with relevant petitions and official transcripts by stipulated deadlines.

Competency-Based Program

The District may obtain approval of a direct assessment competency-based program from the State Chancellor's office.

Catalog Rights

Students who maintain continuous enrollment may elect to graduate under the requirement of the Chaffey College catalog in effect at the time of admission to Chaffey College or at the intended date of graduation from Chaffey College.

Continuous Attendance

Students who have maintained continuous attendance at any accredited college (attendance in at least one semester or two quarters, excluding summer sessions, each calendar year – January 1 through December 31 – as indicated on permanent record) have the option of meeting the current requirements or those in effect at the time continuous attendance began at Chaffey College.

Official Transcripts

In order to apply units completed at another institution toward a degree, official transcripts may be delivered by appropriate electronic means, mailed or hand delivered provided they arrive in an officially stamped and sealed envelope by the issuing institution. Official transcripts have an embossed or water seal.

Transcripts from colleges accredited by one of the regional accrediting associations will be evaluated upon student's request.

Meritorious Service Award

Academic Senate has acknowledged faculty members through meritorious service awards since the inception of the awards in 1986/87. All full-time faculty, living or deceased, who have been retired for at least one full year or who have died while in service, are eligible for the Meritorious Service Award. Faculty receiving this prestigious honor have clearly shown meritorious service in at least two of the following three areas: Superior Teaching or Job Performance, Professional Achievement, and/or College Service. In order that future students and staff will remember their outstanding contributions to Chaffey, their name is placed on the Meritorious Service perpetual plaque that hangs in the library.

Meritorious Service Award Guidelines

Criteria Applications shall clearly show meritorious service in at **least two of the following three areas**, one of which must include Section 3.1. Clear indications in all three may strengthen a nomination.

Criteria to be used in evaluating applications are:

3.1 Superior teaching or job performance

- 3.1.1 Examples of meritorious performance include, but are not limited to, excellence in classroom teaching, significant curricular development, instructional innovations and/or successful completion of special projects or assignments, and significant individual assistance to and/or interaction with students in the learning process.
- 3.1.2 Examples of professional commitment include, but are not limited to, having furthered education by attending special courses and institutes or participating in major professional conferences; projects or developmental materials related to contracts, grants or fellowships for instructionally related work or job performance; other appropriate items related to instruction or job performance.

3.2 Professional Achievement

3.2.1 Examples of scholarly performance include, but are not limited to, publication of juried, refereed, and/or reviewed work; noteworthy exhibitions, performance, and/or other creative work; offices held in professional organizations; panel discussions or workshops organized for professional meetings; active participation in professional meetings (i.e., delivered papers, addresses, etc.); academic innovation in general and/or other appropriate materials related to professional growth.

3.2.2 Examples of academic achievement include, but are not limited to, significant research, investigative activity or creative activity; contract, grant or fellowship-sponsored activity successfully concluded; editing or consulting activity of a scholarly nature; active participation in research related conferences, courses or institutes; and other appropriate activity of an outstanding nature.

3.3 College Service

- 3.3.1 Examples of meritorious performance include, but are not limited to, exceptional leadership in college, governance and campus life at the department, division, campus, and/or state levels; and/or other exceptional service consistent with the college mission.
- 3.3.2 Examples of professional achievement include, but are not limited to, developmental working a service-related project within the college (department, division, campus and/or system); developmental work in a service-related project in the off-campus community (recruitment, outreach, public relations, governmental, etc.); other activity which is likely to produce exceptional service to the college and/or surrounding community.

Academic Senate

The Academic Senate represents faculty in all academic and professional matters. Activities and responsibilities may include or go beyond the following (referred to as the 10+2):

- I. Curriculum, including establishing prerequisites and placing courses within disciplines
- 2. Degree & Certificate Requirements
- 3. Grading Policies
- 4. Educational Program Development
- Standards or Polices regarding Student Preparation and Success
- 6. District and College governance structures, as related to faculty roles
 - a. The appointment of faculty members to serve on college committees, task forces, or other groups dealing with academic and professional matters shall be made by the Academic Senate in consultation with the Superintendent/President or designee.
 - There are some areas where the Faculty Association may appoint faculty to committees.
- Faculty roles and involvement in accreditation processes, including self-study and annual reports
- 8. Policies for faculty professional development activities
- 9. Processes for program review
- Processes for institutional planning and budget development
- 11. Other academic and professional matters as mutually agreed upon between the governing board and the academic senate.
- 12. Hiring criteria, policies, procedures, and equivalencies for new faculty members shall be developed, updated, and agreed upon jointly by representatives of the Governing Board and Academic Senate. (Unique to Chaffey and is not included as the statewide 10 +1).

Dear Academic Senate President Nicole DeRose:

On behalf of the Governing Board, we acknowledge receipt of the recent Academic Senate Resolution, "Action Plan for Increasing Library Staffing in Accordance with Title 5". The response outlines several points that will be elaborated on in the upcoming planning meeting with stakeholders.

- 1. A planning meeting will be organized by the Dean in charge of the Library, Distance Education, and Success Centers to discuss operations and access before the opening of the Library Learning Commons. As we previously discussed, the Library Learning Commons designs, program adjacencies, and access concerns were vetted and approved by numerous campus stakeholders that attended frequent planning meetings with two architects over a nearly 18-month process. Our Library facilities are meant to serve all stakeholders, including students, faculty, and staff. Therefore, the dean will clarify access and operations.
- 2. Per the 2020-2023 CSEA Agreement, a classification and compensation study for the Library Clerk I and II positions was conducted. This study includes market and internal alignment analyses regarding salaries. Additionally, the District and CSEA have been actively working together to update all classified job descriptions for the Library. As you may be aware, the District is completing its recruitment for the Library Clerk I position. Once the job descriptions have been finalized, the Library Clerk II position will also be advertised.
- 3. You referenced AP 4040, stating that "certificated librarians" must be present during library hours. Please note that AP 4040 requires "certificated personnel". Certificated personnel is a term that predates AB 1725. Minimum Qualifications (MQs) replaced certificates/credentials and the term "academic" replaced "certificated". This is also highlighted, for example, in Education Code section 78103, which reflects libraries being supervised by "academic personnel." We will update AP 4040 to change the outdated language from "certificated personnel" to "academic personnel". Of course, faculty are academic personnel, and so are the deans. The Dean overseeing the Library, Distance Education, and Success Centers, as well as those over the Fontana and Chino Campuses, are authorized to supervise these areas. In the absence of a librarian, Deans may allow access to the Library facilities with limited services provided by Library Clerks.

California Code, Education Code - EDC § 78103

The libraries shall be open for the use of the faculty and the students of the community college district during the day. In addition, the libraries may be open at other hours, including evenings and Saturdays, as the governing board may determine. Libraries open to serve students during evening and Saturday hours shall be under the supervision of academic personnel.

Title 5, § 53405. Certificated Employees

Whenever in this Division, reference is made to "certificated employees" or to employees in "positions with certification qualifications," where such references are to certificates or credentials issued by the Board of Governors, these references are deemed to also apply to persons employed by districts pursuant to minimum qualifications established pursuant to Subchapter 4 of this Division.
