

MUST COMPLETE INITIAL TRAINING AND SECURITY AWARENESS TRAINING WITHIN SIX MONTHS OF EMPLOYMENT AND PRIOR TO ACCESS OF CLETS

MUST COMPLETE THE FULL ACCESS EXAM

- ➢ 70% MINIMUM PASSING SCORE (25 QUESTIONS)
- MUST RECERTIFY EVERY TWO YEARS

LEVEL 4 – INFORMATION TECHNOLOGY PERSONNEL (IE. SYSTEM ADMINISTRATORS, SECURITY ADMINISTRATORS, NETWORK ADMINISTRATORS)

INFORMATION TECHNOLOGY PERSONNEL: ANYONE GENERATING ACCOUNTS, IMPLEMENTING SECURITY PATCHES, CREATING BACKUPS AND IMPLEMENTING ACCESS CONTROLS THROUGHOUT THE NETWORK.

REQUIRED TRAINING:

- MUST COMPLETE SECURITY AWARENESS LEVEL 4
 70% MINIMUM PASSING SCORE (25 QUESTIONS)
- MUST RECERTIFY EVERY TWO YEARS

ADMINISTRATORS AND UPPER-LEVEL MANAGEMENT

WHEN A CLETS OPERATOR LEAVES THEIR CLETS WORKSTATION, THEY MUST LOG OFF RIMS. IT IS NOT CONSIDERED SECURE TO JUST LOCK YOUR COMPUTER AND REMAINED LOGGED IN.

- REASONABLE MEASURES SHALL BE TAKEN TO LOCATE EQUIPMENT IN A SECURE AREA TO PROVIDE PROTECTION FROM VANDALISM OR SABOTAGE AND TO PRECLUDE ACCESS OR VIEW BY ANYONE OTHER THAN AUTHORIZED PERSONNEL
- DETAILS OF SUMMARY CRIMINAL HISTORY MAY BE RECEIVED BY AN AGENCY-APPROVED WIRELESS DEVICE, PROVIDED ALL WIRELESS ACCESS SECURITY REQUIREMENTS ARE MET (FBI CJIS SECURITY POLICY 5.5)
- CLETS PROVIDED INFORMATION MAY BE FAXED FROM ONE SECURE LOCATION TO ANOTHER SECURE LOCATION (EMAILS)



CLETS SECURITY CONT.

- PERSONNEL AUTHORIZED TERMINAL ACCESS TO CLETS MAY BE SWORN OR NON-SWORN LE PERSONNEL, VOLUNTEERS, PRIVATE VENDORS AND MAINTENANCE PERSONNEL WHO HAVE BEEN SUBJECTED TO A SECURITY CLEARANCE TO INCLUDE THE FOLLOWING CHECKS (PPP 1.9.2 B):
 - DOJ FINGERPRINT CHECK
 - FBI FINGERPRINT CHECK
 - THE DOJ CRIMINAL JUSTICE DATABASES MAY BE ACCESSED FOR BACKGROUND INVESTIGATION OF LE AND CJ EMPLOYEES WITH THE EXCEPTION OF THE AUTOMATED CRIMINAL HISTORY (ACHS) AND MENTAL HEALTH FIREARMS PROHIBITION SYSTEMS (MHFPS)

CLETS SECURITY CONT.

PERSONNEL SHALL NOT OPERATE CLETS EQUIPMENT OR ACCESS CORI UNTIL A BACKGROUND AND FINGERPRINT-BASED SEARCH IS COMPLETED AND APPROVED BY THE AGENCY HEAD.

IF THE BACKGROUND/FINGERPRINT CHECK REVEALS A FELONY CONVICTION OF ANY KIND, CLETS ACCESS SHALL NOT BE GRANTED.

WHEN A PERSON WITH ACCESS TO CLETS IS NO LONGER EMPLOYED OR NO LONGER ACCESSING CLETS ON BEHALF OF THE LEA, THE AGENCY IS RESPONSIBLE FOR REMOVING ALL RELATED PASSWORDS, SECURITY AUTHORIZATION, TOKENS, ETC., FROM THE SYSTEM





may have access to confidential criminal records, the Department of Motor Vehicle records or other criminal justice information, much of which is controlled by statute. All information from the CLETS is based on the "need-to-know" and the "right-to-know" basis. The misuse of such information may adversely affect an individual's civil rights and violates the law and/or CLETS policies.

Penal Code (PC) section 502 prescribes the penalties relating to computer crimes. PC sections 11105 and 13300 identify who has access to state and local summary criminal history information and under which circumstances it may be released. PC sections 11141-11143 and 13302-13304 prescribe penalties for misuse of state and local summary criminal history information. Government Code section 6200 prescribes the felony penalties for misuse of public records and information from the CLETS. California Vehicle Code section 1808.45 prescribes the penalties relating to misuse of the Department of Motor Vehicle record information

Penal Code sections 11142 and 13303 state:

"Any person authorized by law to receive a record or information obtained from a record who knowingly furnishes the record or information to a person not authorized by law to receive the record or information is guilty of a misdemeanor."

Any employee/volunteer who is responsible for the CLETS misuse is subject to immediate dismissal from employment. Violations of the law may result in criminal and/or civil action.



PROTECTION ORDER FILE (POF)

VPF WAS CREATED SOLEY FOR THE PURPOSE OF ENHANCING OFFICER SAFETY BY PROVIDING A WARNING TO LE OF INDIVIDUALS WHO MAY HAVE A PROPENSITY FOR VIOLENCE AGAINST LE OFFICERS.

RECORDS WILL BE PROVIDED IN RESPONSE TO WANTED PERSON AND VEHICLE INQUIRIES.



ENTRY INTO THE VPS SHOULD BE MADE WHEN AT LEAST ONE OF THE FOLLOWING CRITERIA HAS BEEN MET:

- OFFENDER HAS BEEN CONVICTED FOR ASSAULT OR MURDER/HOMICIDE OR ANY STATUE WHICH INVOLVES VIOLENCE AGAINST LE (FLEEING OR RESISITING ARREST)



The Nation's Silent Mass Disaster

The sheer volume of missing and unidentified person cases poses one of the greatest challenges to agencies tasked with resolving these important cases.

Over 600,000 individuals go missing in the United States every year. Fortunately, many missing children and adults are quickly found, alive and well. However, tens of thousands of individuals remain missing for more than one year – what many agencies consider "cold cases".

It is estimated that 4,400 unidentified bodies are recovered each year, with approximately 1,000 of those bodies remaining unidentified after one year.

- > WHEN OBTAINING AN ADDITIONAL RESIDENCE ADDRESS
- > AFTER INCARCERATION OR CUSTODY COMMITMENT THAT LASTED 30 OR MORE DAYS
- WHEN RESIDING, ENROLLING, OR GAINING EMPLOYMENT AT AN INSTITUTE OF HIGHER LEARNING
- IF THE REGISTRANT IS OR BECOMES A TRANSIENT, HE/SHE IS REQUIRED TO REGISTER NO LESS THAN EVERY 30 DAYS
- IF THE REGISTRANT HAS BEEN DESIGNATED A SEXUALLY VIOLENT PREDATOR (SVP), HE/SHE IS REQUIRED TO REGISTER NO LESS THAN EVERY 90 DAYS.

ARSON REGISTRANTS







DMV MAINTAINS AN ONGOING RECORD OF VEHICLE AND VESSEL OWNERSHIP-INCLUDING ALL VEHICLES/VESSELS REGISTERED OR PLANNED NON-OPERATIONAL STATUS

VEHICLE/VESSEL REGISTRATION FILE IS COMPOSED OF:

- > VIN
- ➢ DESCRIPTION OF THE VEHICLE OR VESSEL

PARKING/TOLL VIOLATION

PER CVC SECTIONS 4770-4771 AND 40220(a), WHEN A PARKING OR TOLL VIOLATION(S) BECOMES DELINQUENT, THE ISSUING AGENCY MAY SEND THE VIOLATION(S) TO CA DMV TO BE PLACED ON THE VEHICLE REGISTRATION RECORD AND COLLECTED WITH THE REGISTRATION FEES.

ONCE PLACED ON THE REGISTRATION RECORD, DMW WILL REFUSE REGISTRATION RENEWAL UNTIL ALL VIOLATIONS ARE PAID IN FULL, OR PROOF OF PAYMENT AND/OR CLEARANCE FROM THE ISSUING AGENCY IS RECEIVED.



OCCUPATIONAL LICENSING

CA DMV IS RESPONSIBLE FOR MAINTAINING A COMPLETE RECORD OF EVERY PERSON OR BUSINESS THAT HOLDS AN OCCUPATIONAL LICENSE (OL). OL RECORD INFORMATION IS ESTABLISHED FROM APPLICATION FORMS

FIRM FILE- ORGANIZATIONS LICENSED BY THE DMV TO DO CERTAIN TYPES OF BUSINESS IN CALIFORNIA. A FIRM MAY BE A DEALER. REMANUFACTURER, DRIVING SCHOOL, VESSEL AGENT, LESSOR RETAILER, DISTRIBUTOR, DISMANTLER, TRANSPORTED, REGISTRATION SERVICES, OR ATV SAFETY TRAINING ORGANIZATION

INDIVIDUAL FILE- CONTAINS THE NAMES OF PEOPLE LICENSED BY THE DEPARTMENT EITHER AS SEPARATE ENTITIES OR CONNECTED WITH THE ORGANIZATIONS STORED IN THE FIRM FILE

INTERNATIONAL REGISTRATION PLAN

THE DMV MAINTAINS AN AUTOMATED RECORD OF COMPANIES THAT REGISTER FLEETS OF COMMERCIAL VEHICLES UNDER THE INTERNATIONAL REGISTRATION PLAN (IRP) PROGRAM.

IT IS A LICENSING AND RECIPROCITY AGREEMENT BETWEEN 47 JURISDICTIONS THAT SETS FORTH THE PROCEDURES FOR REGISTRATION AND OPERATION OF VEHICLES TRAVELING IN TWO OR MORE JURISDICTIONS.

OWNERS MUST ESTABLISH A "BASE JURISDICTION" WHEN REGISTERING VEHICLES. OWNER APPLICANTS DECLARING CA AS THE BASE STATE MUST RESIDE AT AND REPORT A CA ADDRESS.
