## **Chaffey College Daily Crime Log**

The Daily Crime Log is required by the Clery Act to record all criminal incidents and alleged criminal incidents that are reported to the Chaffey College Police Department. Incidents are posted to the Log within 48 hours of being reported, excluding weekends and campus holidays. If a case disposition changes, it will be reflected in the log within 48 hours.

This log contains data from the most recent 60-day period. Any portion of the log that is older than 60 days will be made available within two business days of a request for public inspection.
