  - **Description –** The Veterans Club and the US Army Reserves Unit will be collaborating on a military style fitness competition. The competition will be based directly on the real Army Fitness Test and will help to prove that the competitors can pass the Army's physical requirements. The competition will be point based and the people with the highest points will be the 1st, 2nd, and 3rd prize winners. All points will be based off the the real ACFT point systems that all military personnel are subject to. Liability waivers will be required as well as an age limit of 18+. This event will help to advertise the Veterans Club and helps the community in engaging in healthy physical activity. The competition will have a \$10 buy in for the general public and \$8 buy in for veterans/active duty. We will be using around \$1000 for our fitness event, and we are hoping that this new request will be able to replenish our club account for our next Veterans Club Haunted House and for 4th of July and Veterans Graduation events during the summer.
