

## FAQ: Fall 2021 Student COVID-19 Vaccine Incentive Program Phase 2

### **What are the eligibility requirements for the \$300 Fall 2021 Student COVID-19 Vaccine Incentive Program Phase 2?**

There are two eligibility requirements:

1. First, you must be a currently enrolled (or completed your fast track course(s)) Chaffey fall 2021 student who enrolled in a Chaffey course(s) for the **fall 2021** semester between **September 8, 2021 and October 22, 2021; and**
2. Second, you must submit valid documentation through [MyChaffey Log In](#) by no later than **December 1, 2021** showing you have received either: (1) both of the two-dose mRNA series (Pfizer or Moderna) COVID-19 vaccinations; or (2) the single dose of Johnson & Johnson's Janssen COVID-19 vaccine.

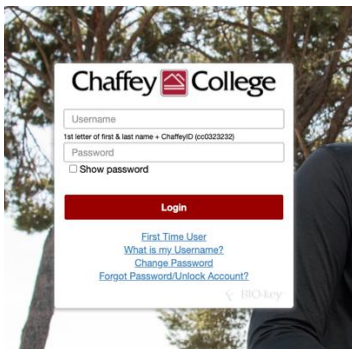
Students who participated/were eligible for the first Fall 2021 COVID-19 Vaccine Incentive Program (those who enrolled on or before September 7, 2021) are not eligible for this Chaffey COVID-19 Vaccine Incentive Program.

### **What does “valid documentation of your COVID-19 vaccination” mean?**

Valid documentation of COVID-19 vaccination for the purposes of this incentive program means the completed Center for Disease Control Vaccination Record Card issued as part of the COVID-19 vaccination process.

### **How do I submit my proof of COVID-19 vaccination?**

- A. Submitting proof of COVID-19 vaccination is easy! Students can submit via the [MyChaffey Log In](#).



- B. Once logged in, you can follow the following steps:
  1. Click on Self-Service (Registration)
  2. In Notifications, go into View Required Documents
  3. Click “Manage” to upload a copy of your vaccination card

**If I already submitted my proof of COVID-19 vaccination, do I need to resubmit to get the incentive?**

No. Students only have to submit proof of COVID-19 vaccination once.

**How and when will I get the \$300 COVID-19 Vaccination Incentive?**

Chaffey College will provide the \$300 COVID-19 Vaccination Incentive to students through a cash gift card or direct payment. Fall 2021 students should anticipate payment in January 2022.

**What if I registered for courses after October 22, 2021, will I be eligible for a future Student COVID-19 Vaccination Incentive?**

You are not eligible for this Phase of the incentive. However, if allocated funds are still available, the College may offer future student COVID-19 vaccination incentive options for spring 2022 students.

Please note, students who participated in the first Fall 2021 COVID-19 Vaccine Incentive Program (those who enrolled on or before September 7, 2021) or this Incentive Program (phase 2), are not eligible for future Chaffey COVID-19 Vaccine Incentive Programs.
