Following past practices, "Honorary titles of Associate Professor and Professor are conferred by action of the Faculty Senate. Advancement from Assistant to Associate and Associate to full Professor may be recommended after eight (8) and fourteen (14) years, respectively." <u>This means</u> that people who have completed eight (8) years will be promoted to associate professor, and those who have completed fourteen (14) years will be promoted to full professor. Certificates will be sent via USPS to all honorees. Keep in mind that honorary titles are based not on the number of years at Chaffey but on the number of years at Chaffey plus those that have been credited.

- Do not want to inhibit people from using their office space. OSHA requires verification of not being sick or exposed. In addition, Facilities need to know who was in what buildings and at what times. The district is legally compelled to complete these documents and individuals are required to wear a mask on campus.

- 8. GUEST(S)/PRESENTATION(S) Faculty Success Center Facilitator, Cindy Walker, has been working with a campus group on drafting a land acknowledgment. They would like Senate's feedback on the Tongva land acknowledgment resolution.
  - **Motion for Approval** Senator Bentum moved to endorse the Tongva Land Acknowledgment. Senator Peoples seconded the motion. The motion was approved. 8.24.21, 23/0.
  - Call to action to continue our knowledge and relationship with the Tongva and Gabrieleño people. Dr. Leticia Romo (she/her/hers) spoke to an elder within the community and received approval of the Land Acknowledgement and the group is seeking edits or suggestions from Faculty Senate.
  - Statement read (1:09 pm)
  - Senator Encarnacion gave the edit of capitalizing the word "Indigenous"
  - Senator Osburn asked when the Land Acknowledgement would be used. FCS Facilitator Walker described that the Land Acknowledgement would also have a "best practices" document to help describe when and where it is best used. They also stated that this current version is an online version, and an in-person Land Acknowledgement would differ slightly.
  - Senator Jenkins stated their relief in speaking with the Tongva people and asked to expand on the conversations with the Indigenous people in the acknowledgment.

- Dr. Romo explained the conversations are a beginning and an opportunity to build a relationship to support students at various levels of education and create intentional outreach with the communities of the Tongva and Gabrieleño people.
- FCS Facilitator Walker described the possibility of creating a scholarship for Indigenous students and hoping for more to come in the future to build these relationships.
- Senator Cotton (she/her/hers) suggested putting this language on the website. In addition, she suggested including a brief history of the Indigenous land.
- Senator Boboye suggested presenting the Land Acknowledgement to the students and receiving their feedback. Guest Ybarra spoke on their excitement for the beginnings of these educational and supportive aspects for Indigenous students, including history and education.

## 9.1 Discussion Item: Covid-19 vaccinations

- The Academic Senate endorses the Governing Boards COVID-19 Vaccination mandate.
- **Motion for Approval** Senator Cotton moved to endorse the Covid-19 vaccine requirement with a statement of endorsement. Senator Tang seconded the motion. The motion was approved. 8.24.21, 14/0/9.
- Senator Peoples mentioned no communication had been sent out and asked for clarification on when communication would be sent.
  - Laura Hope mentioned sending the vaccination cards to <u>HRdocs@chaffey.edu</u> as the current process. Further information is provided from Human Resources regarding what documentation will be considered as "valid."
  - Once submitted to HRdocs there will be no additional requests for verifications.
- Senator Marcus requested clarification on what will be required for students enrolled in FTF classes. The motion presented was in regards to all individuals on campus with a phased-in approach to student vaccinations. Laura Hope stated it will align heavily with the approach to faculty and staff and provide incentives to students.
- Senator Peoples asked for clarification on long-term goals and the time period for the mandate. President Watkins stated that this would be revisited as with many things related to the COVID-19 protocols and safety.

• Faculty office use this semester – email reply from Assoc. Superintendent Laura Hope: The faculty do not need to get permission to come to campus. However, they will need to let their deans know that they were there, so that they can be included in the facilities log.

We have two logs: one is for employees to confirm that they have done the daily selfcheck, and their signatures confirm that they are not experiencing any symptoms of the virus nor have they been exposed. That log is being kept in the deans offices or at people's individual work stations and will be submitted to the deans monthly. We have been told that we need "wet" signatures for those. The second log is for the manager to complete indicating who was in the facilities within their scope. Classroom instructors don't need to be included in this because that's already a given; however, all employees need to be tracked, which is why if people come to campus, they need to let the dean know so that they can log it. This log is required by OSHA for contact tracing purposes. The proposed land acknowledgement:

With respect and honor for the lands that Chaffey College resides on and the leaders before us, we would like to take a moment to acknowledge the Gabrieleño-Tongva (GABRIEL-EN-YO/ TONG –VA) Peoples, the original stewards of these sacred and unceded homelands. The Tongva people's history, language, cultural traditions, and legacy continue to shape this region and we recognize their continuing presence in their homelands.

In the spirit of truth and equity, Chaffey College commits to uplifting the voices of indigenous peoples and transforming the institution to build an inclusive and equitable educational environment. We also encourage members of the Chaffey College community to learn about the original caretakers of the land they reside on and to advocate for culturally responsive action.
