- **10.1 Discussion Item:** ASCCC Resolutions, Nicole DeRose, Area D Report in preparation for Fall Plenary Resolutions for Discussion
  - Senator Holdiness mentioned concerns regarding how Chaffey will be handling and coordinating the process of the transfer pathways and common course numbering in the "Bad Bills" section of DeRose's meeting notes. Accreditation Committee Faculty Tri-Chair DeRose stated that there will be forthcoming information and updates regarding these particular concerns.

**10.2 Discussion Item:** Campus Calendar: possible revision to be more equitable and culturally responsive to include holidays outside of the current Western marked holidays - <u>campus calendar</u> - <u>academic calendar</u>

• Equitable and Culturally Responsive Calendar

- Senator Cotton expressed that many holidays and culturally significant dates in many cultures and religions move and are not on set calendar dates. Having reminders of when these occur would be a positive benefit. Senator Cotton also stated that these dates might be too much to have on something like the events or academic calendar, but creating a separate calendar for cultural and religious observance might be a good middle ground.
- Senator Doget shared a student experience that illuminated the need for a more culturally responsive calendar and awareness in terms of student clinicals. They also stated that it would be beneficial to make it easier for faculty to be aware of potential conflicts due to religious or cultural obligations.
- Senator Peoples expressed that faculty should maintain their personal policies and procedures in regards to how they use the information being distributed regarding cultural or religious holidays. In addition, Peoples mentioned that teaching at a public institution means that in many regards, religious freedom includes the absence of creating emphasis on any religious events. Senator Peoples stated an example of schools celebrating "Winter holiday" or "winter break" instead of "Christmas Holiday" or "Christmas Break."
- Senator Encarnacion emphasized that the goal of this discussion item is to acknowledge holidays. Senator Encarnacion stated that there are many cultural groups where asking for extensions or changes in deadlines creates high power distance and dynamics that might not be culturally accessible to some students. They stated that they respect the academic freedom of every instructor to do with what they want with the knowledge of upcoming cultural or religious holidays throughout the year.
- Students registering for Fast Track courses and student retention
  - Senator Peoples brought forward to the discussion that a potential student trying to register for a Fast Track II course only showcases "Fall 2021" and combines 18-week, 14-week, and both Fast Track courses into the course listings while Fast Track II are the only courses currently open for enrollment.
  - President Watkins stated that this issue might have to do with the fact that the campus has moved away from the Community Ed model to the Transfer and Career Pathways model.
  - Senator Holdiness stated that the conversation regarding technology concerns is different than equity issues with the calendar and wanted to separate the discussion items to make sure each topic was given the breadth deserved.
  - Senator Osburn shared a screen to showcase one of the issues present in this conversation regarding registering for courses. Senator Shelton mentioned that there is an option to only select certain course offerings by scrolling down the screen and filtering the courses shown.

#### **Academic Senate Accreditation Update #1**

Accreditation Tri-Chairs – Nicole DeRose, Hope Ell, and Laura Hope Accreditation Liaison Officer (ALO) - Laura Hope

Accreditation visit will take place in Fall 2023. The Institutional Self Evaluation Report (ISER) is due to ACCJC in Spring 2023 (May).

There are four standards that must be addressed in the ISER.

- Standard I Mission, Academic Quality and Institutional Effectiveness, and Integrity
- Standard II Student Learning Programs and Support Services
- Standard III Resources
- Standard IV Leadership and Governance

#### What has happened so far?

- The accreditation tri-chairs met with our ACCJC liaison on February 24, 2021 for the Initial ISER training.
- The ACCJC liaison facilitated a second ISER training for the accreditation tri-chairs and many additional members of the college on April 23, 2021.
- Accreditation tri-chairs met to review standards, develop the accreditation timeline, and identify classified, management, and faculty to serve as ACCJC Standards Tri-Chairs (formerly standard leads). Along with the accreditation tri-chairs, the standards tri-chairs will form the basis of the Accreditation Oversight Committee (AOC).
  - o The AOC has not yet convened.
  - o An AOC update must still be provided to the Academic Senate.

#### ASCCC Area D Meeting, October 16, 2021 10 am

I. WELCOME AND UPDATE FROM ASCCC President Dolores Davison

**LEGISLATION: Major bills** that are going to have a significant impact on the California Community College System.

#### **Good Bills**

- A good bill is at AB 927. It is around the baccalaureate programs at California Community Colleges. This bill removes the pilot designation. 15 baccalaureate programs so those are no longer pilots, they are permanent. The hope is that they will promote greater enrollment and interest because the programs are not going away.
- Opens up the opportunity for colleges to apply to have a baccalaureate degree. Point of clarification: the baccalaureate programs are primarily applied in CTE fields and they cannot be duplicative have a program offered at a CSU or UC that leads to a baccalaureate degree.
- AB 927 provides the opportunity for 15 colleges per cycle, and there are two cycles per year. There could be up to 30 new baccalaureate programs per year.
- There has been the creation of a baccalaureate board the California Community College baccalaureate Association. ASCCC is continuing to look at we're working with the chancellor's office and how quickly we can get that new baccalaureate application out and get moving on putting more baccalaureate into the California Community Colleges.

#### **Bad Bills**

- AB 1111 calls for the creation of a common course numbering system for all three systems of public higher education.
  - That is something that obviously is going to be quite an undertaking. We have colleges on different calendars. We have compressed calendars we have regular calendars we have semesters we have quarters.
  - The plan was to originally or the original legislation asked for us to use see ID courses first and identify those and bring those into common course numbering.
  - o The bill was amended to allow for the creation of basically a workgroup a council to get together and discuss how to do this.
- AB 928 has three major components.
  - The first is the creation of an inner segmental transfer intersect metal committee on transfer essentially bringing together practitioners and stakeholders from all three systems of public higher education, as well as outside interest groups including the campaign for College Opportunity, potentially, the Department of Education
    - That committee will have four practitioners from our system and appointee from the chancellor's office and appointed by the Academic Senate and then two students. All three systems have the same except that the CCC is are the only ones that have two students everybody else has one.
    - That group is to convene and start discussing the rest of the transfer bill.
  - The second part is the creation of a single general education pattern for all students intending to transfer to the UC the CSU or other transfer institutions, it's calling together. We have until May of 2023 to come up with a pattern. And if we don't the administrations of the three systems will come up with it, and it has to be in place by January 1 2024. They are working on that that is a transfer is the number one priority for the segmental committee of Academic Senate, or I guess this year. And so we will be meeting every month to talk about that and to work out what the best course of action will be on the
  - o The third part is the automatic placement of students who declare transfer as their educational goal or who declare a major which has an associate degree for transfer that those students were automatically placed on an ADT pathway. So if you have a student

- that comes into your college and says, I want to major in psychology. They are automatically placed on the psychology path toward an ADT if they choose to they can opt out, but they are, it is an automatic placement, we express significant concerns about this for a variety of reasons, including that for many of our colleges. The ADT pathway does not work.
- O This is opposed by every single practitioner group. There will be a Coordinating Committee on transfer, gather together at some point in the near future it will be chaired for the first two years. They will continue to look for how we can deal with this. there is no funding in the bill for this. It does stay in the bill that you can use your Guided Pathways funds. And it also suggests that we can embed this in our local enrollment software.

#### Other

- AB 1456. ASCCC did not take a position on this bill, but were in support of.
  - This was the Cal get grant reform bill that would have significantly changed the way that Cal Grants operated and would have given our students many more opportunities to receive grant funding.
  - o This bill was supported by a significant number of advocates including fact, including the Student Senate and the governor vetoed it, stating that it would cost too much money.

#### **RETURN TO CAMPUS**

- The Chancellor has made it very clear we are not reopening as colleges were never closed. The term is returning to campus rather than reopening.
- ASCCC has received a significant number of questions about vaccine mandates mask mandates and the role of the Academic Senate in those that is largely your local relationship with your union. We have seen everything across the board.
- The decisions are local. The chancellor's office is not going to interfere with what local boards of trustees are doing the board of governors and the acting Chancellor put out a letter in August talking about following the science around vaccines and masks. The Chancellor's office has made it abundantly clear that it is not their role to dictate what locally elected boards decide to do for their campuses.

#### **ENROLLMENT**

- Enrollment is down across the state at the majority of the community colleges.
- A recent article in Ed Source revealed the UCs and the CSUs are seeing upticks in enrollment, and the community colleges have lost about a quarter of a million students.
- There are a number of reasons for the enrollment decline. Community college students were the most impacted by the pandemic in terms of
  - o having to go from part time or from full time to part time in order to work more hours.
  - o Many of them are parents and they had to stay at home and work with their children.
  - They were precluded them that from necessarily being able to take classes.
  - Food and housing insecurities are higher for community college students compared to UC/CSU students.
  - Declining birth rate in California has lead to reduced enrollments in K12 districts, high
    cost of living, moving out of districts to secure more affordable housing or to attend
    private schools, leaving the local area or state.
  - o Many campuses are asking faculty to contribute to increasing enrollment and ways that enrollment can be increased through faculty efforts. There is a webinar next week with the chancellor's office to talk about that. ASCCC is not suggesting that this be required or that it be part of your required duties, it will simply be a discussion of ways that faculty can reach out to students, both in terms of retention and in terms of recruitment.

#### THE BROWN ACT

- AB 361 extended the provisions about the Brown Act/Public Meetings Act. The Board of Governors uses until January 31 2022. The governor did not have to extend the executive order that allowed for public meetings to take place through teleconferencing.
- Most boards of trustees are going back or have gone back in person. The Board of Governors, at its September meeting did have several board members say that they felt they should be back in person in November, since most other school boards are going back in person.
- President Davison is expecting that since the chancellor's office does not intend to open until probably January, and expects the Board of Governors will continue to remain online.
- Many campuses do not have a space large enough to allow for social distancing for Academic Senate meetings or for any other Brown Act committee. The current Brown Act provisions allow for teleconferencing if you post the location ahead of time and make it accessible to the public, at least through the end of January. We are in a position where we're meetings can continue to be virtual.
- The Student Senate is meeting today and they are in person, with the option of hybrid.
- ASCCC Executive Committee meetings have been in person with the opportunity for members to be hybrid. Must wait to see what the governor decides to

#### ASCCC AREAS OF FOCUS FOR 2021-2022

- The Executive Committee adopted three areas of focus for the Academic Senate this year, two of them are repeats from last year.
  - Culturally responsive curriculum, students support student services, continuing the antiracism decolonization an abolitionist work of last year around that.
  - Equity driven systems continuing to look at the Diversity, Equity and Inclusion work being done at the chancellor's office in conjunction with all of the practitioners around the state.
    - Talking about evaluations, this is a big topic this year, all evaluations to include all college employees, including administrators, classified professionals, full-time and part-time faculty.
  - Transfer. ASCCC continues to emphasize that with our segment partners and with others.

#### **OTHER**

- Administrative turnover is high right now. Some colleges have no senior administrators in permanent positions. As a result, it is chaos on the state level in terms of administrators, the average tenure for a CIO is three years, the average tenure for a CEO is less than three years, and when you knock out the people that have been in their positions for a really long time. The averages most see CEO president superintendents are in their positions for two years or fewer. That is chaos and it does not serve the students well, if the campus is in a state of flux all the time.
- Faculty and the classified professionals are usually the ones that are around for the long haul.
   Participation in hiring committees and efforts around evaluations ensure accreditation work are really going to be important going forward and so I thank all of you for all the work you're doing.
