10.1 Discussion Item: Tuition and Fee Waiver for all Gabrieleño-Tongva and American Indian students

- CSU and UC's have initiated these types of fee waivers.
- Chaffey has anywhere from 0.2-0.3% of students self-identifying as American Indian/Native American.
- Senator Shelton asked what process would occur for students to receive this fee waiver. Senator Encarnacion stated that the process of identification should remain as self-identification from the students and not follow the current UC standard of checking current tribal enrollment or of the Bureau of Indian Affairs, given issues with those systems and the ability to be federally recognized and/or registered. Senator Johnson echoed this sentiment and added that the Gabrieleño-Tongva peoples are not federally recognized, only recognized by California.
- Senator Osburn stated that writing a statement to go alongside this issue from the Academic Senate to explain reasoning and explanation. Further conversation ensued from multiple senators regarding what would be included in such a statement.
- Motion for Approval Senator Shelton moved to recommend that the college explore the tuition fee



waiver for Gabrieleño-Tongva and American Indian students. Senator Jackson seconded the motion. The motion was approved. 11.15.22, 23Y/0N/1A.

• Take aways

• Ethnic Studies programs began in the 1960's and stemmed from student demand and the movement away from traditional disciplines. This is educational area is not new; has been in place as established programs for over 50 years.

• Cross-listing may weaken the development of an Ethnic Studies program if the crosslisting is not driven by the Ethnic Studies faculty. If cross-listing does occur, let the Ethnic Studies faculty determine potential cross-listing. This will provide space and opportunity for growth and development of the curriculum and program.

- Ethnic Studies courses are now required
 - California Community Colleges: Title 5 <u>Title 5 §55063(e)(3)</u>:
 - Satisfactory completion of a transfer-level course (minimum of 3 semester units or four quarter units) in ethnic studies. The requirement may also be satisfied by obtaining a satisfactory grade in a course in ethnic studies taught in or behalf of other departments and disciplines.
 - Required for all students beginning in fall 2024
 - California State University: AB 1460 (Weber, 2020) Ethnic Studies
 - CSU GE Breadth Area F Ethnic Studies
 - The requirement to take a 3 semester (4 quarter) unit course in Area F shall not be waived or substituted
 - University of California: Effective fall 2023
 - IGETC Area 7 Ethnic Studies
 - 1 course: 3 semester units or 4 quarter units. This course must be in ethnic studies or a similar field provided that the course is cross-listed with ethnic studies.
 - **California High School**: AB 101 (Medina, 2021) High School Graduation Requirements: Ethnic Studies
 - 1 semester course in ethnic studies for students graduating in 2029-30
 - HS students may seek dual enrollment options to fulfill this requirement

 - African American Studies

- Chicano Studies
- Asian American Studies
- Native American/American Indian Studies
 - This year a proposal to more closely match the Ethnic Studies minimum qualifications to the four autonomous disciplines of Ethnic Studies.
 - Hearing at the Fall 2022 Plenary
 - Hearing, Debate, and Consideration at the Spring 2023 Plenary
- <u>Ethnic Studies Courses and Programs</u>
 - Ethnic Studies C-ID Course descriptors and Transfer Model Curricula (TMCs) are currently being vetted.
 - Process started with three Discipline Input Group meetings in Spring 2021.
 - A Faculty Discipline Review Group consisting of 4 CCC and 4 CSU faculty one representative from each of the four core disciplines from each segment was established.
 - Draft C-ID descriptors and 5 TMCs (Ethnic Studies plus the four core disciplines within Ethnic Studies) went to CCC and CSU faculty for feedback.
 - Faculty feedback is being considered, and if changes are proposed, more vetting will occur.
- While C-ID descriptors and TMCs are under development:
 - Work with Ethnic Studies faculty, Curriculum Committees, and Articulation Officers to anticipate and meet student needs for Ethnic Studies curriculum.
 - Note that GE courses and major courses often double count
 - Consider student need/interest and course possible articulation agreements when developing courses and local (i.e. non-ADT) degrees/certificates.
- Articulation of Ethnic Studies Curriculum
 - UC Intersegmental General Education Transfer Curriculum (IGETC) Area 7
 - CSU CSU GE Breadth Area F
 - UC and CSU agreed to reciprocity in approval of CCC Ethnic Studies meeting GE requirements
 - Obtaining CSU GE Breadth Area F approval has had its challenges (see resolutions table above)
