6. DE Addendum Recommendations and Best Practices: Jonathan Ausubel presented the Online Education Initiative's Course Design Rubric. Jon emphasized that there should be instructor initiated contact with students in both hybrid and fully online course. He shared a general principle that there are multiple means of contact throughout the semester for instructor-student contact and student-student contact. Jon focused on Section B: Instructor/Student Contact of the rubric which outlined the best elements for pre-course contact, regular effective contact, student-student contact, student-student contact, and students, and student participation level.

The Chair suggested that someone from the DE committee serve on the Technical Review Committee to completely vet DE proposals via the rubric presented.

- 7. Curriculum Submissions Report: The Curriculum Specialist announced that 276 proposals have been launched in the queue since August 2019. There are a total of 337 items in the queue including the items on today's agenda. She also shared that out of 440 courses due review per Title 5 this year, 215 courses still need to be updated. She will contact Deans and Coordinators about these updates.
- 8. Curriculum Tip of the Day: The Curriculum Specialist provided a breakdown of the second half of the COR elements required by Title 5 to guide curriculum members on what to review in their curriculum readings. She outlined elements for review in a course's content, objectives, methods of instruction, out-of-class assignments, methods of evaluation, and texts and supporting references.

9. Discussion Items:

- **9.1. Open Educational Resources Initiative (OERI) Events:** The Chair shared that there two events to discuss OER resources and needs. The event in Southern California is October 26, 2019 in Garden Grove.
- **9.2.** Curriculum Representative Reviews: The Curriculum Specialist reminded the Curriculum Representatives to wait 3-5 days before completing their reviews. In this review, they will check to see if a few discipline faculty have read the proposal. Since there are varying numbers of faculty in each discipline, a set number of reviews cannot be given for discipline review; however, faculty were informed via email that they have 3-5 days to do their discipline review.

GE Workgroup Meeting 09.25.19

In attendance: Angela Burk-Herrick, Julie Law, Patricia Powell, Rob Rundquist, Sean Stratton

Topics discussed included:

- The development of criteria for inclusion of courses in General Education (GE) areas.
- Recommended GE coursework for different Academic and Career Communities (ACCs)

I. GE Area Criteria

The group discussed different ways to approach the criteria for inclusion of courses in GE pattern. The CSU-GE and the IGETC patterns have established criteria and a copy of "Guiding Notes for General Education Reviewers" (October, 2018) was handed out (<u>https://www2.calstate.edu/csu-system/administration/academic-and-student-affairs/academic-programs-innovations-and-faculty-development/geac/documents/GE-Reviewers-Guiding-Notes.pdf</u>).

It was discussed that an outcomes based approach that began with developing student learning outcomes (SLOs) for each GE Area might be a good place to start. Once SLOs are established for each area, rubrics can be created for evaluation of courses. It was noted that efforts on this front will require broader campus involvement than just Curriculum Committee members (discipline faculty, counseling faculty, etc.). The Outcomes and Assessment Committee (OAC) was identified as a group that might help coordinate this work. The discussion of how and when to begin a campus wide discussion ensued. Ideas included Spring FLEX, Spring Faculty Lecture Day, and/or sometime this Fall.

NEXT STEPS: Reach out to OAC to propose GE Area SLOs workgroup representation.

II. ACCs and GE

Because Academic maps are available for most degrees and the maps were used to create an excel file, information on which GE courses are recommended in the different ACCs is available. This information could be used to provide students who are unsure of the specific degree they are interested in with some high impact GE courses that would most likely help them make progress towards any degree and/or any degree within and ACC.

NEXT STEPS: A copy of the Excel file will be made available to the workgroup for discussion.

Transfer Course Level Policy

Transfer Level Courses (Chaffey course numbers 1-99)

A course is considered to be transfer-level if it is accepted toward the baccalaureate degree by UC or CSU and/or is accepted for transfer credit to the UC or CSU systems (CB05).

A course meets transferability requirements if:

• It articulates with a C-ID course descriptor and is approved through the C-ID approval process (C-ID is a statewide course numbering system used to facilitate transfer and articulation across California's higher education institutions).

AND/OR

• It is equivalent to a **lower division** course offered at 4 year accredited colleges and universities.

There are several ways that evidence of transferability can be established when submitting a course for Curriculum Committee approval. In the **comparable course** section of Curricunet, submit evidence for ONE of the criteria listed here:

- 1. Provide the C-ID course descriptor (see C-ID.net) that articulates/aligns to the course you are proposing. Note: If a C-ID articulation does not yet exist (e.g. for new courses), the Articulation Officer (AO) will submit the final COR to *** for review, after the course has been approved by our local governing board. Once the C-ID articulation decision has been made, the AO will....
- 2. If no C-ID course descriptor is a good fit with your proposed course, provide two examples of **lower division** comparable courses at CSUs or UCs.
- 3. If no C-ID or comparable courses exist at CSUs or UCs, provide two examples of **lower division** comparable courses at other 4 year accredited colleges and universities.
