7. Discussion Items:

- 7.1. Local GE Patterns and Other GE Patterns in META: The Chair shared that Chaffey's curriculum management systems have included the CSUGE and IGETC patterns because they are certificates of achievements, but not Chaffey's local GE pattern. The Curriculum Office would like to develop a page in META that allows the Articulation Officer to create and modify the local GE pattern in META. This development would also apply to the CSUGE-STEM, IGETC-STEM, and UC Transfer Pathway GE patterns. A committee member asked about the benefit to students to obtain a local GE pattern over the CSUGE and IGETC patterns. The AO answered that the math competency for the local GE pattern is intermediate algebra, and the math competency for the transfer pattern is fulfilled by courses such as college algebra, statistics, and personal finance. She also added that the local GE pattern requires three to four less courses than the transfer GE patterns. Since many CTE majors have high units, the lower unit GE pattern ensures that students will complete their program with the appropriate amount of units. The Chair shared that most academic maps include the transfer GE patterns if the units allow, but some high unit programs benefit from the local GE pattern as well. Getting these additional patterns in META will help with the technological modifications needed and will allow for better alignment between these GE patterns.
- **7.2. Voting Process Document:** The Chair shared a document that outlines a more streamlined way to vote in our Zoom curriculum meetings. This document would be a formal representation of how the committee is voting during virtual meetings. Some changes to procedure include a verbal roll call for attendance at the start of the meeting and the option for committee members to request a roll call for certain motions.
