- 1. Call to Order/Roll Call: The meeting was called to order at 1:35p.m.
- 2. Public Comment: Dr. Friday greeted the committee.

4.1. Curriculum Chair: The Chair spoke on the recent updates for Brown Act during the pandemic. In Academic Senate, a vote will be held every 30 days to continue meeting via zoom. Their vote will apply to how the Curriculum Committee will host meetings as well. She also reported that Dr. Shannon has hired two full-time Ethnic Studies faculty to begin teaching the Ethnic Studies

courses next fall. Lastly, The Chair shared that she and the Specialist went to the Dean's meeting to share a PowerPoint on the Standard Update Cycle and Diversity, Equity, and Inclusion (DEI) efforts in curriculum. The presentation and DEI opportunities in curriculum were well received and commended.

A comment was made to include "American Indian and/or Indigenous" in addition to Native American in the title. The Chair shared that when the full-time Ethnic Studies faculty come, they will be asked to review the CORs and make edits based upon their expertise. Another comment was made on whether Latin(a) and Latin(o) should be LatinX. The AO shared that they used the terms presented in the COR competencies for these courses. The Curriculum Office will change the language to LatinX on all CORs. The critical thinking assignment will be adjusted to replace "compare and 		17/0/0

A committee member noticed that the rationale for the modality on the DE page was missing. The Curriculum Office will work on expediting the revisions to the DE page.

The Chair shared that she spoke to the originator of the math courses on why they believe these courses should be Fully Online Emergency Only. The originator shared that the retention and success rates for these courses have been extremely low in a fully online environment. In addition, the department has concerns about how to adequately assess student learning online. Therefore, the department has voted for a Fully Online Emergency Only modality. The Curriculum Office will put this rationale on the proposals.

A member discussed the possibility of asking faculty to share data with their rationales on the DE page, especially when discussing success and retention rates. Another member shared that this burden of proof should not fall on the faculty for review by the Curriculum Committee, and there are courses that do not work well in a fully online environment. They also mentioned that courses should not be forced to fit this modality if it is not pedagogically sound. One member mentioned that having a rationale does not mean the committee will make an approval decision based upon that rationale. Rather, the rationale helps the committee understand the faculty's choice of modality and is not a means to override the faculty's choice. Rob Rundquist mentioned the need to discuss how individual courses can be successfully delivered in a fully online environment. These discussions should be based upon department consent and not individual preferences. Jonathan Polidano mentioned that some employers in advisory committees have addressed concerns about certain courses being offered fully online. He suggested faculty also think about industry needs and inputs when deciding a modality. The Chair feels having a rationale/notes/comments section in META for modalities will address the points the committee members discussed.

7. Discussion Items:

- **7.1. Curriculum Review Guide/Resources Endorsement:** The Specialist shared the resources that she and the Chair made to guide faculty through the upcoming standard update cycle. The Chair and Specialist wanted the Committee's endorsement to post these materials on the website since many of the resources were created based upon the committee's input, feedback, and suggestions. The Committee gave their endorsement.
- **7.2. AP/BP 4260 Prerequisites and Co-requisites:** The Chair called for volunteers to read AP/BP 4260 for the cyclical review of APs and BPs. Christina Holdiness and Lisa Doget volunteered.
- **7.3. Updated Curriculum Committee Scope and Purpose Draft:** The Chair shared the updates to the Scope and Purpose of the committee. She added that the committee will commend exemplary work in addition to review of curriculum. She also added to the purpose that the committee will advance Chaffey's goals on Equity and Success, Learning and Completion, and Community Opportunities and Needs. There was motion to approve the revised scope and purpose, to add the revised version to the By-Laws, and to include the revised scope and purpose where needed. The vote was approved 18/0/0. Here is the new purpose and scope of the Committee:

Purpose: The Curriculum Committee is a representative group of professional staff that functions as a college-wide standing subcommittee of the Chaffey College Academic Senate and in a recommending and advisory capacity to the Associate Superintendent of Instruction and Institutional Effectiveness in matters related to the college curriculum. *Under the direction of the Academic Senate, the Curriculum Committee develops curriculum processes that advance Chaffey Goals on Equity and Success, Learning and Completion, and Community Opportunities and Needs (see Chaffey College, VISION 2030 Educational Master Plan, February 2020).*

Scope: The Curriculum Committee provides certification to the Chancellor's Office that processes and procedures align with California Education Code, Title 5 regulations, and the Chancellor's Office Program and Course Approval Handbook (PCAH). The committee's purview includes the maintenance and development of a professional quality curriculum as well as the following activities:

- The systematic review of proposals to change program and course curricula.
- The investigation of evaluative instruments to measure the effectiveness of program curricula.
- The regular and systematic review of graduation requirements, transfer certification requirements, and other matters related to the curriculum as a totality.
- The examination of the curriculum for unwarranted duplication of courses.
- Course approval delegated to the college by the Chancellor's Office.
- Annual systematic review of program effectiveness in conjunction with the Program and Services Review (PSR) Committee.
- Systematic review of articulation agreements (high school, career technical education, and baccalaureate).
- Commendations of faculty and departments that make exemplary use of the curriculum process to foster institutional goals including institutional learning outcomes, student success and completion, sustainability, and DEI (diversity, equity, and inclusion).
