- d. **Undocumented Student Week of Action during the week of October 18th -22nd** - The Outreach Committee will discuss collaboration or actions with the Center for Social and Cultural Justice for Undocumented Student Week. The Committee will discuss the possibility of contributing CCSG swag items to the event that will be no more than \$250 such as 5-10 bags of CCSG SWAG items. The Outreach Committee will discuss ways to promote this event online and/or on social media accounts.
- e. **Resignation of Outreach Senators and Vacant Senator Positions** - Two senators have resigned from CCSG from the outreach committee and other members are no longer an active.
