

PTA Program - Application Instructions

Please note that applications must be fully completed and submitted online with required document attachments. Incomplete applications will be denied. Please review the instructions carefully and/or meet with a Chaffey College Counselor for assistance.

A. <u>Steps **prior** to the Evaluation and Application Periods</u>

- Become a Chaffey College Student New or returning students to Chaffey College must complete the
 <u>online Application for Admission</u> to receive a Chaffey College Student ID number and/or reactive your
 account. New students will receive a Chaffey College Student ID number within 15 minutes of
 submitting their Chaffey College application via email. Continuing students do not need to reapply to
 Chaffey College.
- 2. Submit ALL official college/university transcript(s) For courses completed at another college, students MUST submit official transcripts to Admissions & Records at the Rancho, Chino or Fontana campuses during regular business hours. Official electronic transcripts can be sent to Chaffey College's Admissions & Records at transcripts@chaffey.edu via official electronic sources. Official sealed, paper transcripts can be dropped off in-person at the Rancho, Chino or Fontana Admissions & Records Departments during regular business hours or mailed to Admissions & Records same address as above.
 - a. Please plan accordingly to send your college transcripts to Admissions & Records and verify they have arrived by speaking with an Admissions staff member via QLESS or inperson **BEFORE** submitting your PTA Program Evaluation Request Form. The PTA Program cannot verify if your transcripts were received.

B. <u>Steps **during**</u> the Evaluation Period - During the months of January & <u>February</u>

1. Complete the PTA Program Evaluation Request Form

The PTA Program Evaluation Request Form can be found on the PTA program's website.
 Student's evaluation request forms will only be processed during the following evaluation periods:

Evaluation Period: January 6th, 2025 through February 13th, 2025 by 4:00 p.m. for spring 2025 applications. Students are recommended to submit evaluation request forms ASAP to give the appropriate amount of time for processing.

Application Period: February 1st, 2025 through February 28th, 2025 by 11:59 p.m.

- The PTA Program Evaluation Request Form MUST be completed to receive a copy of your PTA Program Evaluation that is required to submit with your PTA application.
- Students will be required to complete an updated PTA Program Evaluation Request Form each time that they apply.



C. <u>Steps **during**</u> the Application Period – Please read this area carefully. Applications will be accepted ONLINE ONLY

 Complete all sections of the PTA program application - The PTA program application link will go live on the PTA program website on February 1st, 2025 at 8:00 a.m. through February 28th, 2025 by 11:59 p.m. Incomplete applications will not be accepted – there are no exceptions.

- 2. Students are only permitted to apply once per application period. There are no exceptions.
- 3. Students are required to upload the PTA Program Evaluation Form completed by the Evaluation Office indicating eligibility for the program. Students must also indicate whether they agree or disagree with the eligibility determination and provide an explanation if they disagree
- 4. Falsification of any documentation will disqualify applicants from entering the program.

D. <u>Steps **after** the Application Period</u>

Applicants will be notified of their application status via email by the week of March 3rd, 2025. If you do not receive information about your application status by the week of March 10th, 2025, you may contact the PTA program for a status inquiry at pta@chaffey.edu
