## Measure P Funding Update Summary:

- First Bond Issuance Resolution
  - \$200 million; Receipt of the first bond proceeds on September 24, 2019
  - \$200 million; Receipt of the second bond proceeds on January 21, 2025
- Refunding Resolution (Measure L)
  - Refunded \$50 million+, saving taxpayers over \$6 million on their Measure L tax bills

## Consultant Procurements (Program Level):

• DSA IOR Inspection Services Consultant Pool scheduled for release Summer 2025

## Phase 1 Project Work Update:

#### • Rancho Cucamonga campus:

- New Library/Learning Commons Project Building exterior skin comprised of Taktl panel and glazing installation work ongoing. Interior drywall installation nearly complete, interior painting work ongoing. Low-voltage data installation work is ongoing. Electrical transformer has been installed, building scheduled to be energized July 2025. Substantial completion targeted for early October and final Project completion in November 2025.
- MACC Renovation Project Structural Steel at 95%, metal deck installed, roofing started and ongoing, Slab-on-grade is complete. In-wall utilities at existing building first floor at 90% completion. Project completion scheduled for Spring 2026.
- Swimming Pool Renovation Project Project completed and closed-out at DSA. Notice of Completion for the project filed at the county office.
- Campus-wide Boiler Retrofit Project Project completed and closed-out at DSA. Notice of Completion filed, Retention released for the contractor.
- Old Library TI (for swing space)- Conceptual design completed and Design Development in progress. Construction documents to DSA submission in work.
- New Campus Center Student Services Building- data collection in works for determination of department and occupants for this new building.

#### Chino campus:

- Chino IB Project College obtained occupancy on May 28th. Few remaining punch-list items work ongoing. Notice of Completion filed at the county after receiving approval from the Governing Board at June 2025 meeting.
- Chino MIB Secondary Effects- Architect Design services proposal under review for the project. Next steps include working towards a full design and submission to DSA for approvals, then to bid award and construction.

#### • Fontana NEW campus:

Phase 1 Project: New DBE team (Swinerton & DLR Group) contract award approved at the May Governing Board meeting. Notice to Proceed with Preconstruction and design activities issued; Schematic Design phase started and ongoing.

#### • Ontario NEW campus:

Design-Build Criteria Architect in process with Stakeholder/User Group engagement for establishing design criteria for campus development.

#### ADA Barrier Removal Project for Rancho Cucamonga and Chino campuses:

- Rancho Cucamonga campus:
  - Phase 1 and 2 site area work projects Project work completed, and the Notice of Completion filed at the county after approvals by the Governing Board at May 2025 meeting. DSA project close-out in works and ongoing.
  - Phase 3 building work projects The project work to be evaluated upon completion of Facilities Master Plan Re-vamp work.
- Chino campus:
  - Phase 4 Project ADA project construction bid package planned to be combined with the drive-way approach and off-site work along Eucalyptus Ave upon receipt of permits from the City of Chino; including the Chino MIB Secondary Effects project.








## **UPCOMING ACTIVITIES**


