In an era of journalistic suppression and the devaluing of higher education, I find it highly concerning that a college investing \$75 million into a new library would just “forget” to account for the thousands of titles housed in the old library. Maybe it was an honest mistake in measurement, but it seems to me that this feels like a targeted attack on access to education.

Dear Academic Senate Governing Body and Senators, hear me out. I am not trying to be alarmist, but the library being forced to deselect books feels like an embarrassing oversight or a calculated plan. Afterall, there are dozens and dozens of new office spaces that were intentionally accounted for to replace *old* office spaces.

Imagine telling taxpayers that we spent \$75 million of Measure P money on a new, better, bigger library, but we forgot about the books. Imagine how that might look to the public. They see the dedication ceremonies, the Costco sheet cakes, the plaques, the hand-painted murals, and assume that Chaffey thought of their students and planned for everything right down to the ribbon cutting.

Except the books. The powers that be forgot about the books in the new library. That feels like a joke or at the very least Orwellian.

Additionally, this tasks librarians with an enormous chore, forcibly having to deselect books without their normal due diligence or processes.

Lastly, I'd like to point out the irony that it's fiction books that are being deselected. *Brave New World*. 1984. *Fahrenheit 451*. The consumers of physical books are mostly fiction readers! So to

decide that it's fiction that must go feels, again, like something akin to a plot point in a dystopian novel.

In *Fahrenheit 451*, firemen burn the books. At Chaffey, Librarians are forced to disappear books.

I urge Senate to continue to express our frustration and frankly, outrage at how this administration loves to congratulate themselves on a job well done without considering the full impact of their choices or at least checking the measurements twice.

7. Report(s)

7.1. President

7.1.1. At the Academic Issues Group (AIG) meeting on Friday, February 6 the group discussed the concerns faculty raised regarding waitlist processes. Themes that came forward included system functionality, focusing on the waitlist not displaying on the faculty portal after the course start date creating confusion and unnecessary burden for faculty adding students, as well as leading to the secondary theme of student confusion and seat inaccuracies, where students trying to find sections to add do not see a visible waitlist, and at times if a student has dropped, may even see open seats, while the instructor is working through the backend to add waitlisted students and must now communicate with other students via email to let them know that there are not actually open seats in the course - despite what the course search is showing. A third theme that was brought forward was the length of period between the start date of a 18-week course and the deadline to add being in week 3, which can impact the students academic success and instructional effectiveness, resulting in faculty creating their own rules and manual workflows to manage enrollment to varying degrees. Chief Technology Officer, Mike Fink was present at AIG and was able to take these concerns back to his team to work on the concerns and CIO McClellan will be updated in regards to what concerns will be easily remediated and which concerns will need further communication and follow up from the Academic Senate and the Office of Instruction.

I spoke with CIO McClellan regarding the concerns facing LLC 130's naming. I will continue to collaborate with CIO McClellan and the Executive Team regarding the involvement of faculty in the naming process of LLC 130. CIO McClellan is aware of the faculty's concerns and further conversations are needed on this topic in order to reach mutually agreed upon naming conventions for the LLC Center space in relation to the already established Success Center on the Rancho Campus. More information will be forthcoming as this topic evolves.

8.1. **Action Item:** Board Policy and Administrative Procedure Revisions - Academic Senate review/possible recommended changes to the following Board Policies and Administrative Procedures. 8.1.1. BP 3810 Claims Against the District (Senator Chamberlain) - Senator Chamberlain and President Encarnacion had no suggested changes in their review.

8.1.2. BP 5030 Fees (Senator Hines-Tinsley) - Senator Hines-Tinsley and President Encarnacion had minor recommended changes to correct sentence structure. The biggest recommended change is in the Instructional Materials section. “The District will work to ensure student access to textbooks....” in order to align with legislation. There was a discussion around the confusion with the Enrollment fee definition because it is also a per unit fee, and the Baccalaureate fee is also a per unit fee in addition to the Enrollment fee; why is this one specified as a per unit, but Enrollment fee is not? To address the confusion Senator Polidano recommended ...LIZ added this directly in the google doc.

8.1.3. BP 7150 Evaluation and Professional Growth & AP 7150 Evaluation (Senators Doget & Keller) - Senator Doget and President Encarnacion had no suggested changes. Senator Keller and President Encarnacion had recommended changes to language and bullet-point order.

- 8.1.11. BP 7295 Letters of Recommendation (Senator Doget) - Senator Doget and President Encarnacion recommended changing “Letters of Recommendation” to “Letters of Recommendation for Employment” for more specified focus.
- 8.1.12. **Motion for Approval** - Senator Chamberlain moved to approve all the recommended changes to the APs and BPs. Senator Liu seconded the motion. The motion was approved. 2.10.26, 24Y/0N/0A.

8.2. Discussion Item/Possible Action Item: Senator Farrand will lead a discussion on Regular and Substantive Interaction (RSI) updates and exploring a local district definition.

- 8.2.1. Senator Farrand reviewed the final two slides of the RSI presentation and noted that, while Chaffey already has a working definition of RSI through the Distance Education checklists, faculty training has omitted student-student interaction because it is not included in contract language, despite being required by the college’s Administrative Procedure (AP). Questions arose regarding evaluation practices, particularly in courses where it is unclear how much and to what extent instructor involvement can be measured when using publisher-created content, supplemental materials, and grading platforms. The discussion also addressed the distinction between policies (that can be enforced) and departmental guidelines (that are encouraged) that could help establish minimum RSI standards collaboratively, emphasizing that Academic Freedom should be carefully balanced in this process.
- 8.2.2. **Motion for Approval:** Nicole Farrand motioned to form a workgroup to explore the need for a local definition of RSI and address the disconnect in the local evaluation of RSI and ACCJC evaluation of RSI. Senator Villeneuve seconded the motion. The motion was approved. 2.10.26, 24Y/0N/0A.
