I. Recap of committee assignments

II. Moodle

Terri Helfand was invited to give an overview Moodle. She want the AOC and the Moodle Team to understand what Moodle can do, what works, what makes sense, and to limit the scroll of death. Terri walked AOC through the login steps to access the AOC Moodle page. Terri gave an overview of the current functionality including:

- A. Toggling-collapsing or expanding topics.
- B. HTML blocks- adding text or images on the course page.
- C. Polling-which allows the creation of customized polls that, allows detailed response information.
There are two types of polls:
 1. Choice-allows multiple or limited response options.
 2. Opinion-choice with room for comments
- D. Single file upload-where we can give a due date for submission. This functionality will stop accepting documents after the due date.
- E. Voice thread-a coming feature-which allows embedding of a message through phone, text or with a mic.

The AOC team has the ability to view everything in course. Terri suggests we visit www.moodle.org to see additional functionality and to keep abreast of updates to the Moodle community.

III. Sub-Committees Review
