Mission Statement Revision

The purpose of this meeting is to discuss revisions to the newly drafted mission statement and vision statement which reads:

Vision Statement:

Chaffey College: Improving lives through education

Mission Statement:

Chaffey College inspires hope and success in a dynamic, supportive, and engaging environment where our diverse students learn and benefit from foundation, career, and transfer programs.

The Governing Board felt the vision statement was fine but the language from the vision statement should be included in the mission statement. Discussion was also held about the mission statement reflecting our educational excellence and our benefit to the broader community that we serve.

The committee suggests the following revised draft mission statement which incorporates the vision statement into the mission statement:

Chaffey College inspires hope and success by improving lives and our community in a dynamic, supportive and engaging environment of educational excellence where our diverse students learn and benefit from foundation, career, and transfer programs.

The newly drafted vision statement will remain unchanged.

These statements will be forwarded through the shared governance process and presented at the September Governing Board Meeting for adoption.
